
Is-sena l-oħra, id-Dipartiment għall-Gvern Lokali nieda l-iskema ta' għajnuna finanzjarja għas-servizz ta' *streaming* tal-laqgħat *online*. L-idea ta' din l-iskema kienet sabiex tgħin lill-Kumitati Reġjonali u lill-Kunsilli Lokali jaħdmu b'aktar trasparenza u jkunu aktar viċin in-nies. Hafna Kunsilli Lokali laqgħu din l-inizjattiva u llum diġà qed ixandru l-laqgħat tagħhom *online*.

Peress li din l-iskema hija parti mill-*policy* tal-Gvern Ċentrali, dawk il-Kunsilli Lokali li għadhom ma bdewx dan il-proċess, qegħdin jintalbu jittrasmettu l-laqgħat tagħhom *live* fuq l-*Internet* sa **mhux aktar tard mill-31 ta' Diċembru 2014**. ## BASIC SPECIFICATIONS FOR ONLINE STREAMING

(the words "Local Council" or "Council" shall also refer to "Regional Committee")

### General Rules for the streaming of the Local Council Meetings

1. Local Councils are to stream the proceedings of the regular Council meetings via the internet.
2. The public is expected to access the stream by entering the *Local Council website* and being led through clear instructions to a web page containing the streamed material.
3. Given that meetings usually take place with Council members seated around an oval table, such meetings are to be covered by a **minimum of 2 cameras**. It is required that a facial view of each Council member shall appear from at least one camera image.
4. Audio is to be picked up by professional table microphones. The voice of each member is to be distinctly recognizable irrespective of position around the table. The number of microphones should reflect this condition **and minimum of microphones should be 2**.
5. When factoring for streaming viewership, considerations for heavy viewership must be included. It is envisaged that certain Council meetings covering controversial topics may be viewed by hundreds or even thousands of households. The streaming service should be compliant with this.
6. The Local Council is not expected to hold either the equipment or the adequate bandwidth to cater for such loads. As such, streaming is to be achieved by first transporting the camera images and audio out to a remote streaming provider via an internet service provided by the Local Council.
7. It shall be the *remote* streaming provider that would possess all the necessary resources, both in processing power and bandwidth allocation, to cater for the worst case loading scenarios.
8. The successful bidder should provide a maintenance and support agreement for a **minimum of 4 years**, separate from the price structure from the streaming hardware and stream services.
9. As per Item 5 above, it is important that the streaming company proposed is of an international reputable performance as well as it should guarantee no limitation on the viewership capacity.
10. During the streaming, external advertisements and/or banners that may appear on the screen are strictly not allowed.

### Internet Provision, and Camera Bandwidth and Resolution

1. The Local Council shall be responsible for the provision of an internet service adequately sized for the purpose of this project. This is fundamental so that the transmission delay will not exceed 10-20 seconds.

2. The Local Council is being encouraged to engage a service option with an upload speed of at **least 1.5Mbps**. Using a 50% overhead rule, this would allocate 750kb/sec for the delivery of video and audio. This is fundamental and can be achieved from all local Internet Service Providers by upgrading the existing service.
3. In view of the above, each camera shall **transmit at a constant bit rate of 375kb/sec**.
4. The successful contractor shall assist and support the Local Council with all the necessary arrangements so that the right service is purchased, installed and tested.
5. The successful contractor shall be **responsible to create all port forwardings** on the modem provided.

## **Streaming**

1. The streaming **provider must provide proof that it carries the necessary redundancy** in resources and be able to demonstrate a documented historical uptime in excess of **99.99%**.
2. Winning contractor is to enter into an independent agreement with the Streaming provider. The Local Councils shall never have to contend with any issues pertinent to this agreement.
3. Streaming provider shall be able to transmit the video and audio content created at the Local Council in the format it was originally made.
4. Streaming service provider shall be capable of distributing video and audio content in a popular streaming technology such as Flash, Quicktime or Microsoft Smooth Streaming.
5. The successful contractor should provide the option to supply the Local Council with a backup of the streamed meetings. This should also include the cost, in the event that the Local Council wishes to place this recording ON DEMAND on the Council's website.
6. As a minimum, the winning contractor must adequately demonstrate that the partner streaming service provider is capable of delivering 750kbps \* 2000 users, i.e. 1.5Gbps without being itself the source of any potential bottleneck.
7. The winning contractor is required to include, a price for the provision of 36 hours of streaming that cover a period of one year (12 \* 3hour monthly meetings) in the final offer. Rates are to be included for cases where this annual provision is exceeded.
8. No external advertisements/banners shall appear during the streaming.

As in the General Rules' section above, it is important that Items 5, 6 and 7 are complied with.

## **Liaison with the Local Council website administrator**

1. Winning contractor shall liaise with the administrator of the Local Council website to implement the final stage of the project which is the production of the page on the website that outputs the camera images and sound, so as to make the streaming service accessible to all through a user friendly approach.

2. To this effect, the winning contractor is to supply **the code that should be embedded** on the said page.
3. Cameras should be positioned in such a way that they complement the normal page style of the website (either besides or on top of each other).
4. One camera should carry a title containing Local Council name, time and date. Both cameras should carry the Local Council logo.
5. Camera specifications in the next section will ask for the cameras to support the NTP protocol. Time and date shall thus be synchronized to a public time server.

## Camera Specifications

1. Professional Hi resolution Cameras must be of the **IP** type.
2. Image sensor : ¼" Progressive scan CMOS or better.
3. Camera must carry an interchangeable CS mount lens. Standard 4mm f1.2 lens to be provided but a replacement may be asked for if the case arises.
4. Light sensitivity better than 0.6lux at f1.2.
5. Video compression : H264.
6. Resolution : selectable from 640\*480 down to 160\*120.
7. Frame rate : selectable from 30fps downwards in all resolutions.
8. Compression : variable.
9. Must support variable and constant bandwidth.
10. Must support multi-streaming : H264, M-JPEG and MPEG-4 Part 2.
11. Images settings are to include colour, brightness, sharpness, contrast and white balance. Exposure control.
12. Must be able to **overlay camera title, time and date on the images.**
13. Must be able to **overlay the Local Council logo at a preselected position on image.**
14. Must support an external audio microphone or line input.
15. Must support AAC audio compression at variable bit rates.
16. **Supported Protocols to include IPv4/6, http, https, RTSP, RTP, NTP.**
17. Power : POE IEEE803.3af Class 1.

## Network Switch

1. An 8-Port Gigabit switch is to be provided.
2. 4 of the ports shall support POE IEEE803.3af Class 1.
3. Total power provision over 4 POE ports : > 53Watts.
4. Interfaces : AUTO Negotiation/AUTO MDI/MDIX.

## Microphones

1. Qty 2 \* high quality table gooseneck microphones are to be provided.
2. Microphones are to be at least 30cm in length.
3. Microphones are to be of the condenser type with a super-cardioids pattern.
4. Microphones should be phantom powered at 48Vdc.

## Audio Mixing Equipment

1. Mixer should have at least 2 microphone inputs with XLR connectors.
2. Microphones shall be phantom powered from the mixer.
3. Each channel on the mixer shall have input gain, various equalization options and post equalization gain controls.
4. In case of a stereo mixer, pan right and left facilities should be available.
5. Mixer should have a final gain control.
6. Unbalanced line outputs should be available.
7. A mix of the table microphones shall be streamed together with one of the cameras.

## Local Council obligations

1. It is recommended that all Local Councils should have their meetings streamed live by end of this year.
2. The above streaming equipment should be in place at all Local Councils by not later than 31 October 2013 in order to have at least 2 test meetings streamed before we go live in January 2014. In order to benefit from the scheme proposed, purchase agreements and fiscal invoices should be presented to the Department by **not later than 31 October 2013**.
3. Apart from the fiscal invoice, the Local Council should provide proof of the Streaming and Maintenance support agreement with the successful bidder for at least 4 years, i.e. 2014-2017.
4. The scheme proposed will allow each Local Council to be financed by a maximum of **€ 2,300** upon approved certification and confirmation of the above. Certification will be performed from the Department independently from the Local Council and the successful bidder.
5. Each Local Council is to **effectively promote the streaming** of each Council meeting through its media activities including newspapers, social networks, newsletters and Council magazine, and by information provided on the Council website.
6. The Local Council should at no time switch off the video and audio stream along the course of a meeting, unless a technical failure occurs.


