Dear Mr. Cutajar,

Following our exchanges with regards to the case of Mr. Joseph Attard, kindly note that Excess under the respective policy is € 583 therefore, the amount being claimed by this Third Party falls within the policy Excess.

Nonetheless in order to guide you we would like to raise the following points.

- Although Mr. Joseph Attard presented a police report there is nothing to indicate that the 'incident in question' occurred in the road in question. The police report was lodged at the Police Station. From a technical and legal point of view, Mr. Attard has to present credible independent witnesses and/or cctv images of the event as it occurred. Otherwise one is inclined to presume that this 'incident' may have occurred on any other road on the Isle.
- The black and white photo's presented do show various cracks and potholes though again these photo's are undated, untimeed and do not even indicate that they may have been taken in Triq is-Suq, Fgura. It is best that you check and verify this aspect and we trust that since the 3rd of February 2012, this road has been since re-asphalted if in the need.
- We ask if any members/employees were given the opportunity on the same day of the incident to examine the condition and/or the tyre of Mr. Attard's vehicle. Is this tyre still available for inspection?. It is quite normal to give a 4-6 year lifespan to a tyre which averages circa 8-10,000km per year. As such you would have the right to deduct a percentage per year from any settlement that you might wish to make on a without prejudice basis to the claimant. We would suggest that this settlement is done against a signed Discharge Form if liability is being accepted.

Please let us know if you require anything further from our end.

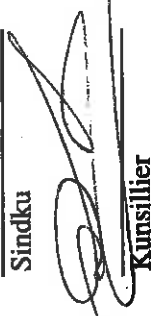
