13.1 Qari tal-ittri ta' Apoloġiji

- 13.1.1 Is-Segretarju Eżekuttiv informa li kien irċieva notifika mingħand Wistin Vella ma kien possibli li jingħaqad għal din il-laqqgħa. Il-Kunsill qabel i jaċċetta din l-apoloġija u għalhekk is-Sur Vella ser jitpogġa bħala Assenti b' Apoloġija għal din il-laqqgħa.

13.2 Konsiderazzjoni u Approvazzjoni tal-Minuti

- 13.2.1 Il-minuti tal-aħħar laqqgħa tal-Kunsill kienu ġew iċċirkolati minn qabel mis-Segretarju Eżekuttiv lill-membri tal-Kunsill u għaldaqstant ġew mequġa bħala moqrija u approvati.
- 13.2.2 Il-minuti tal-aħħar laqqgħa għalhekk ġew ippreparati biex ikunu iffirmati mis-Sindku u mis-Segretarju Eżekuttiv.

13.3 Komunikazzjoni mis-Sindku

- 13.3.1 Is-Sindku informa li kien irċieva rapport li ntrema materjal tal-kostruzzjoni fil-wied ta' Bingemma. Wara li s-Segretarju Eżekuttiv bġhat korrispondenza lill-kumpanija tat-trakk li deher jarmi, l-iskart tneħħa fi' żmien 24 siegħa.
- 13.3.2 Is-Sindku ta rendikont fuq l-attivitá tal-ġħoti tad-demmi li saret fis-26 ta' April u li ġħaliha kien hemm rispons tajjeb ħafna tanti li kien hemm 46 donatur u anke iċ-ċentru tat-trasfużjoni tad-demmi irringrazzja lill-Imġarrin li kienu tant ġenerużi.
- 13.3.3 F' Misraħ is-Sebbieħ ukoll intrema ammont ta' skart u materjal li ġie imnaddaf.
- 13.3.4 Bejn it-8 u d-9 ta' Mejju waqgħu xi blat fuq iċ-Ċikken il-Ġnejna. Sar rapport immedjat lid-Direttorat tal-Protezzjoni Ċivili u lill-Pulizija u qed isir studju fuq jekk ġħandu isir xi intervent.
- 13.3.5 Is-Sindku informa li kien sar aċċident bil-van tal-Kunsill li kien misjuq mill-handyman tal-Kunsill, fi Triq Sir Harry Luke. Sakemm il-van qed jigi rrangat, kellu jinkera vann ieħor biex ix-xogħol tal-Kunsill jibqa' ġħaddej.
- 13.3.6 Sar proġett ta' refreshing tal-linji tal-parkeġġ fil-Ġnejna peress li ħafna minnhom kien tħassru.
- 13.3.7 Ġie installat clothes-bank ieħor ħdejn it-tnejn l-oħra fil-Housing Estate peress li t-tnejn kienu qed jintlew malajr wisq.
- 13.3.8 Saret kmemmorazzjoni qasira f' ġieħ il-vittmi tat-Tieni Gwerra Dinjija fil-VE-Day u sar ornament bil-fjuri quddiem il-monument tal-Gwerra mal-faċċata tal-binja tal-Kunsill.
- 13.3.9 Is-Sindku ta informazzjoni dwar il-proġett tan-New Water li ġħaddej mill-Imġarr u spjega kif kien issuggerixxa lill-WSC biex jġħaddu minn trejqiet differenti biex ikun hemm inqas problemi ġħar-residenti u l-bdiewa.
- 13.3.10 Is-Sindku informa li kien ġħaddej xogħol fuq il-ġiebjá tal-proġett tal-mixtla f' Tal-Facciol. Dan kien xogħol li kellu jsir immedjatament minħabba l-istruttura tat-tħaffir u tal-ġiebjá infisha.

13.5 Temi oħra ta' xogħol tal-Kunsill Lokali li jkunu meħtieġa

13.5.1 Is-Segretarju Eżekuttiv informa li wara li l-Kunsill hareġ sejha għall-kwotazzjonijiet għas-servizz ta' book-binding tal-Minuti tal-Laqgħat tal-Kunsill, kien irċieva kwotazzjoni waħda, jiġifieri dik ta' Orion Book-Binders Ltd. Is-Segretarju Eżekuttiv sħarreg din il-kwotazzjoni u kkonferma li kienet favorevoli ħafna. Barra minn hekk ix-xogħol ta' din il-kumpanija kien jidher serju u magħmlu b' sengħa u galbu. Il-Kunsill qabel unanimament li jilqa' din il-kwotazzjoni u jagħti dan ix-xogħol lil Orion Book-Binders Ltd.

13.5.2 Is-Segretarju Eżekuttiv ressaq risoluzzjoni li kella tiġi approvata biex il-Kunsill ikun jista' japplika għall-Online Banking System tal-Bank of Valletta. Din ir-risoluzzjoni kienet taqra hekk :

RESOLUTION FOR ONLINE BANKING SERVICES FROM BANK OF VALLETTA

The following is an extract of the minutes of a meeting held on Monday 18 May 2020:

The meeting was informed that the Local Council was considering whether to operate its bank accounts with Bank of Valletta p.l.c. (hereinafter the "Bank") and whether to otherwise deal with the Bank via the Bank's alternative delivery channels that may currently be accessed through internet, fixed line telephony and mobile telephony.

At the meeting there were tabled a copy of the Important Information and Terms and Conditions of Use of the said delivery channels.

It was resolved to approve all the said documents which were duly approved by the Local Council in their form and content.

It was further resolved:

- (1) to apply to operate all bank accounts with the Bank and to otherwise deal with the Bank via the Bank's alternative delivery channels that may currently be accessed through internet, fixed line telephony and mobile telephony;
- (2) that the said Mr CYPRIAN DALLI holder of ID Number xxxxxxM¹ be duly appointed system administrator with the power to appoint the following users;
 - Ms NATASHA CASSAR, holder of ID Number xxxxxxM ;
 - Ms DORIANNE MIFSUD, holder of ID Number xxxxxxM ;
- (3) that the powers and authorities granted by the Local Council to the said Mr. CYPRIAN DALLI as system administrator shall be unlimited save in so far as any limitation applies to the Local Council itself; and are and shall remain continuing and binding on the Local Council until such date as the Local Council shall have notified and the Bank received due notification of their amendment or revocation;
- (4) that any changes to the persons appointed as system administrator or other users shall have no effect until such date as the Local Council shall have notified and the Bank received due notification of such changes;
- (5) that this resolution shall not in any way effect any instructions of the Local Council given to the Bank regarding the operation and management of the Local Council's affairs other than via the Bank's alternative delivery channels and that such other instructions shall remain continuing and binding on the Local Council until such date as the Partnership shall have notified and the Bank received specific notification of their amendment or revocation.

13.5.3 Is-Segretarju Eżekuttiv ressaq riżoluzzjoni oħra sabiex il-Kunsill ikun jista' japplika biex ikollu Electronic Point Of Sales (EPOS) tal-Bank of Valletta. Ir-riżoluzzjoni kienet taqra hekk:

Board Resolution Of the MĠARR LOCAL COUNCIL for Signing a Merchant Agreement with Bank Of Valletta Plc.

The following is an extract of the minutes of the Board of Directors of the Company held online on Microsoft Teams due to the current regulations for mitigation of the COVID-19 spread, and usually held at 22, Triq Sir Harry Luke, Mġarr on 18 May 2020. The meeting was informed that the Company intends to apply for Card Acceptance facility/ies with Bank of Valletta p.l.c. (hereinafter the "Bank").

At the meeting there was tabled a copy of the Merchant Agreement which regulates the provision of the said Card Acceptance facility/ies. It was resolved to approve the said documents which was duly approved by the Board in its form and content.

It was resolved that:

1. to apply for the provision of the Card Acceptance facility/ies by the Bank to the Company.
2. that the following person/s be duly authorised and empowered to represent the Company and to sign and execute any one or more Merchant Agreement/s well as any other document that may be necessary in this respect and to bind the Company thereby: Mr PAUL VELLA (Mayor) ID No xxxxxxM Mr CYPRIAN DALLI (Executive Secretary) ID No xxxxxxM
3. that the powers and authorities granted by the Company hereby to the said persons/s shall be unlimited save in so far as any limitation applies to the Company; and are and shall remain continuing and binding on the Company until such date as the Company shall have notified and the Bank received due notification of their amendment or revocation

4. this Resolution shall not in any way effect any instructions of the Company given to the Bank regarding the operation and management of the Company's affairs other than the Merchant Agreement and that such other instructions shall remain continuing and binding on the Company until such date as the Company shall have notified and the Bank received specific notification of their amendment or revocation.

Il-Kunsill approva unanimament din ir-riżoluzzjoni.

- 13.5.4 Il-Kunsilliera Tiziana Borg Busuttil ressqet proposta sabiex issir tip ta' kompetizzjonita' tpingija u crafts kif ukoll attivita' b' karattri sabiex ifferħu lit-tfal waqt iż-żmien tal-COVID-19. Il-Kunsill iddiskuta u qabel fil-principju dwar dan.
- 13.5.5 Il-Kunsillier Clayton Gauci ressaq proposta biex il-Kunsill jibda' jistudja il-possibilita' li jkun hemm talbiet mis-sidien tal-istabbilimenti tal-ikel u x-xorb biex jagħmlu użu minn art privata biex jarmaw barra minħabba ir-restrizzjonijiet tal-COVID-19. Il-Kunsill qabel li jibda' jara dwar din l-eventwalita'.

13.6 Kunsiderazzjoni u Approvazzjoni tal-Iskeda tal-Pagamenti

- 13.6.1 Is-Segretarju Eżekuttiv ressaq l-iskeda tal-Pagament numru 5/2020 li kienet tammonta għal €50,735.32.

- 13.7.1 Is-Segretarju Eżekuttiv ressaq għall-attenzjoni tal-Kunsill l-Estimi Finanzjarji tas-sena 2019 wara l-Awditjar u l-Aġġustamenti proposti.
- 13.7.2 Il-Kunsill ra l-aġġustamenti kif ukoll l-estimi rrangati, u wara li studjahom fir-reqqa, approvahom b' mod unanimu.

13.8 Sejħiet għall-offerti

- 13.8.1 Is-Segretarju Eżekuttiv informa li kien hemm bżonn li jinħarġu żewġ sejħiet għall-offerti bl-E-Tendering, jiġifieri għas-servizzi ta' sinjali u tabelli tat-toroq kif ukoll għas-servizzi ta' Contracts Manager. Il-Kunsill approva unanimament li dawn iż-żewġ sejħiet joħorgu.
- 13.8.2 Il-Kunsill iddiskuta wkoll il-possibilita' li jara li jkollu servizz ta' sapport u manutenzjoni tas-sistemi tal-IT li kull ma jmur qed isir aktar servizz kritiku għall-operat tal-Kunsill. Il-Kunsill qabel b' mod unanimu li dan għandu jsir.
