1. QARI U APPROVAZZJONI TAL-MINUTI

Is-Sindku ippropona li l-Minuti tas-Seduta nru.267 ikunu approvati bħala dokument korrett. Il-Kunsillier Emanuel Cutajar issekonda u l-Kunsill qabel b’mod unanimu.

2. PUNTI LI JOHORĠU MILL-MINUTI

2.1 Triq il-Għid/Triq Papa Pawlu VI

Is-Sindku qal li l-arrangamenti ġodda ġew implimentati. Huwa kompla jgħid li l-Perit tal-Kunsill issuggerixxa li jitwaħħlu tabelli kif ukoll isir sinjal mal-art “Stop” fi Triq il-Għid. Is-Sindku ppropona li jsiru dawn ix-xogħlijiet. Il-Kunsillier Jesmond Tanti issekonda u l-Kunsill irrizolva favur b’mod unanimu.

2.2 Għar Lapsi

Is-Sindku qal li x-xogħolijiet tax-xibka tlestew u huwa kien ġie mistieden mill-Uffiċju tal-Ministru Mizzi biex jattendi *press conference* li nżammet mill-Ministru stess fuq il-post.

2.3 Knisja tal-Providenza

Is-Sindku qal li kien għadu qed iħejji l-*Byelaw*. Huwa qal li flimkien mas-Segretarju Eżekuttiv kellu laqgħa maċ-*Chief Executive Officer* tal-MTA dwar dan il-proġett. Dan minħabba li b'mod abbużiv ittaqbu numru sostanzjali ta' toqob biex jintużaw għall-bandalori jew oġġetti oħra tal-festa. L-MTA lesta li tirrangà din il-ħsara li tammonta madwar €8,500 imma qed titlob l-għajnuna tal-Kunsill biex din il-ħsara ma tirrepetixruha.

Barraminhekk qed jitolbu wkoll li t-triq li mir-*roundabout* tagħti għall-kappella tingħalaq għat-traffiku biex b'hekk it-*turf* li sar ikun jista' jikber. It-traffiku jista' jidhol minn toroq alternattivi.

Il-Kunsillier Jesmond Tanti issuggerixxa li nikkonsultaw mar-residenti u bdiewa tal-*vicinanza* tal-kappella.

2.4 Revizjoni tas-South Local Plan

Is-Sindku qal li flimkien mas-Segretarju Eżekuttiv hu kien iltaqa' ma' uffiċjali tal-MEPA fejn il-Kunsill kien infurmat dwar kif se jsir il-proċess tar-revizjoni.

Is-Sindku ippropona li min-naħa tagħna norganizzaw laqgħa pubblika dwar dan il-pjan nhar il-Ħamis, 12 ta' Settembru. L-għan ta' din il-laqgħa m'għandux ikun biex nisimgħu ilmenti individwali imma dawk ta' natura li tolqot lill-komunità b'mod ġenerali.

Il-Viċi Sindku issekonda u l-Kunsill qabel b'mod unanimu.

2.5 Festa Għeneb

Is-Sindku qal li l-preparamenti kienu mexjin kif ippjanati. Bħala parti minn din il-festa se tinbena vaska kbira tal-ġebel li se tintuża għall-għasir tal-għeneb. L-inizjattiva se tiddaħhal fil-*Malta Records*. Is-Sindku informa lill-Kunsill li l-Banif Bank kien aċċetta li jagħti sponsorship għal din l-attività. Huwa kompli jgħid li parti mill-programm se jkun jikkonsisti f'tixrid ta' informazzjoni dwar il-*Millenium Development Goals* bħala parti mill-proġett ta' SCREENS.

Huwa qal ukoll li se ssir konferenza stampa li se jattendi għaliha s-Segretarju Parlamentari Dr José Herrera. Din se ssir nhar it-Tnejn 19 t'Awwissu fin-12.30pm.

2.6 Restawr tal-Istatwa ta' San Pawl
