1. BIDU TAL-LAQGHA

- 1.1. Eżatt wara t-talba l-Kunsillier A Grima staqsa jekk l-*istreaming* kienx qiegħed jiffunzjona. Meta kien imwieġeb li għadu ma jiffunzjonax, huwa pprotesta għaliex sostna li fl-aħħar laqgħa l-Kunsill kien imwieġħed li qed isir ix-xogħol biex sal-laqgħa li jmiss is-sistema tkun qed tiffunzjona.
- 1.2. Is-Sindku infurmatu li din kienet laqgħa straordinarja imsejja b'urgenza u meta fil-laqgħa preċedenti semmiet il-laqgħa li jmiss kien ifisser il-laqgħa skedata li jmiss u mhux laqgħa b'urgenza li ma tistax tkun taf meta se tiġi msejja.
- 1.3. Il-Kunsillier A Grima però insista li l-Kunsill ma żammx il-wegħda u għalhekk iddikjara li se jitlaq mil-laqgħa bi protesta.
- 1.4. Eżatt warajh, għall-istess raġuni, telqu wkoll il-Kunsillieri Tabone u Bugeja.

2. NUQQAS TA' QUORUM

- 2.1. F'dan il-ħin kien fadal preżenti s-Sindku u l-Kunsillieri Fenech, Vella u Bezzina u għalhekk minħabba nuqqas ta' *quorum* il-laqqgħa ma setgħetx titkompla.
- 2.2. Kien diskuss x'għandu jsir f'sitwazzjonijiet simili u jekk hemmx ħin li l-Kunsill għandu jistenna sakemm jabbanduna l-laqqgħa. Kien hemm ukoll Kunsillieri li kienu fi triqithom għall-Kunsill.
- 2.3. F'dan il-ħin wasal il-Viċi Sindku li però hekk kif ra li m'hemmx *quorum* reġa ħareġ mil-laqqgħa f'it wara. Il-ħin kien is-18:45.
- 2.4. Sadanittant wasal il-Kunsillier D Grima. Il-ħin kien is-18:47.
- 2.5. Is-SE ikkonsulta l-Ordni jiet Permanenti iżda dehrlu li dan kien każ pjuttost ambigwu u li qatt ma kien iltaqa' miegħu. Dehrlu wkoll li l-ligi ma titkellimx b'mod ċar x'għandu jsir.
- 2.6. Sar għalhekk tentattiv mis-SE biex isir kuntatt telefoniku mad-Direttur tal-Gvern Lokali iżda ma kienx hemm twegħiba.
- 2.7. Is-SE għamel ukoll kuntatt ma' Uffiċjal mill-Monitoring Unit tad-DLG u li wkoll ikkonferma li qatt ma kien iltaqa' ma' każ simili iżda miegħu iddiskuta ċirkostanzi li jistgħu b'xi mod ikunu simili.
- 2.8. F'dan il-ħin wasal il-Kunsillier Piscopo. Il-ħin kien is-18:55.
- 2.9. Sar kuntatt telefoniku mal-Kunsillier Cremona li kien wiegħed li se jattendi. Huwa kkonferma li qiegħed fi triqtu għal-laqqgħa.
- 2.10. Is-SE dehrlu li l-ligi mhux daqstant ċara ta' x'għandu jigi f'każijiet simili. Huwa fakkar li għali kien hemm każijiet fejn kien hemm *quorum* bl-eżatt u Kunsillier ikollu jillarga mil-laqqgħa u b'hekk il-laqqgħa jkollha tieqaf għal f'it sakemm jerġa jirritorna t-tali Kunsillier. F'dawn il-każijiet m'hemm l-ebda ħin speċifiku sakemm tista' ddum tistenna qabel titkompla l-laqqgħa u għalhekk, il-fatt li kien hemm Kunsillieri li wegħdu li se jigu u kienu fi triqithom, allura kien jagħmel sens li wiegħed jistenna u ma jisfrattax laqqgħa speċjalment li hija laqqgħa b'urgenza.
- 2.11. Wasal il-Kunsillier Cremona fis-19:08 u, wara li gie spjegat dak li ġara, u la darba f'dak il-ħin kien hemm il-*quorum* meħtieġ, kien maqbul li l-laqqgħa titkompla.

3. HLAS TA' KONTIJET

- 3.1. Kienet ippreżentata l-iskeda ta' pagamenti.
- 3.2. Wara li kienu kjarifikati xi mistoqsijiet, il-Kunsill approva l-lista b'mod unanimu. Din hija annessa f'A.
- 3.3. Reġa gie mressaq il-kont ta' Piscopo Gardens li jmur lura għall-Kunsill preċedenti. Is-SE spjega li, irrispettivament mill-fatt li l-ordni tax-xogħol mill-Kunsill preċedenti lil dan il-kuntrattur kienet irregolari, huwa ma kellu l-ebda tort u għalhekk, la x-xogħol kien sar, kellu jithallas. Jekk dan il-ħlas ma jsirx allura l-Kunsill ikun suġġett għal ħafna aktar spejjeż ta' qrati.
- 3.4. Is-SE kien mistoqsi dwar jekk il-Kunsill preżenti jkunx qiegħed jidher li huwa stess qed jimxi kontra r-regolamenti jekk ikun effettwat il-ħlas issa. Huwa wiegħed li r-records jibqgħu juru li l-iżball sar meta inħarġet l-ordni u mhux issa.

- 3.5. Is-SE kompli fakkar li huwa fl-interess tal-Kunsill li, la darba jaf fiċ-ċert li dan il-kuntrattur għandu kull dritt li jithallas, għandu jevita kwistjonijiet legali li jirriżultaw fi spejjeż inutili. Fakkar ukoll li anki d-Dipartiment issuġerixxa li jithallas kemm-il darba jkun ikkonfermat li x-xogħol twettaq.
- 3.6. Il-Kunsill imbagħad unanimament qabel li dan il-kont għandu jithallas.
- 3.7. Fuq proposta tal-Kunsillier Cremona kien hemm qbil li ssir ordni biex ikunu miżbura ammonti ta' palm għall-valur totali ta' massimu ta' €1160. Il-prezz taż-żbir għal kull palma huwa: palma żgħira - €10, palma medja €20 u palma kbira bl-użu tal-highup €40. Madanakollu f'dan l-istadju ix-xogħol għandu jsir fuq dawk l-aktar żgħar biex ikun evitat periklu għall-pubbliku.
- 3.8. Fuq proposta tal-Kunsillier Piscopo kien hemm qbil li jitpogġa bank fl-inħawi ta' fejn il-Posta ta' San Pawl.

4. HRUĠ TA' STQARRIJA

- 4.1. Is-Sindku talbet lill-Kunsill sabiex jiddiskuti materji urġenti relatati mal-attivitàta' Lost and Found li kienet ser tibda l-għada tal-laqgħa. Il-Kunsill qabel.
- 4.2. Is-Sindku infurmat, li din il-ġimgħa, il-Kunsill kien ġie infurmat minn TM li se jingħalqu toroq ewlenin bejn għada u nhar il-Ħadd matul ħinijiet differenti tal-ġurnata minħabba l-party. Dan sar bla ebda konsultazzjoni u mingħajr ma r-residenti huma infurmati.
- 4.3. Hija kompliet li talbet għal aktar informazzjoni iżda ma ġietx imwieġba.
- 4.4. Is-Sindku spjegat li infurmat lill-Kummissarju tal-Pulizija sabiex ikun hawn preżenza ikbar ta' pulizija fil-lokalita' u talbet l-assistenza tad-Direttorat tat-Tindif għall-għajnuna fit-tindif tal-lokalita', hekk kif sar f'okkażjonijiet oħra. Is-Sindku spjegat ukoll li ltaqat mal-organizzaturi fejn talbet il-kollaborazzjoni tagħhom rigward is-sigurta' u t-tindif.
- 4.5. Għaldaqstant kien hemm qbil unanimu li l-Kunsill għandu joħroġ stqarrija dwar dawn il-punti, kontra l-għeluq tat-toroq, u anki biex ikunu infurmati r-residenti, liema stqarrija għandha ssemmi wkoll li l-Kunsill mhux kontra dawn it-tip ta' attivitajiet li jiġġeneraw in-negozju iżda li għandu jkun hemm konsultazzjoni u arranġamenti minn qabel mal-Kunsill Lokali.
