Purpose of the processing	The personal data collected on this form will be held securely and will only be used for administrative purposes in relation to your request and to record the withdrawal of the previous consent.
Legal basis for processing	By signing overleaf, you have withdrawn your consent for us to use your image/s to publicise events or council services, in newspaper articles, magazines and other media such as TV, websites, social media, information leaflets, electronic newsletters and presentations. We need to process your data to entertain your request
Categories of personal data	We will be storing your name, date of birth, last 4 digits of an ID document and contact details.
Use of personal data	We may use your personal data to contact you about your request and to record and entertain your request.
Transfer of data out of the EU/EEA	We will not transfer your personal data outside the EU/EEA.
Retention Period	Your personal data in our withdrawal of consent register will be held in accordance to the Council's data retention guidelines. In this case 2 years after the last entry.
Data subject rights	You have the right to request a copy of the information we hold about you, the right to ask us to rectify, erase or restrict processing of your data, the right to ask for data portability, the right to object to automated decision making, and if we are relying on consent the right to withdraw consent at any time.
