
Re: Tender for collection of refuse in Sliema

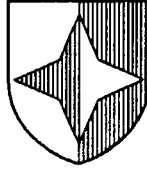
